MAXIMUM PRINCIPLE FOR ONE PROBLEM OF STOCHASTIC OPTIMAL CONTROL WITH VARIABLE DELAY

Abstract

The stochastic problem of optimal control with variable delay is considered. At first the necessary condition is obtained for stochastic systems without phase limitation. Further using Ekland variational principle the maximum principle is proved for stochastic control systems with delay of phase limitations.
